Monitoring and evaluation can assure sustainability. According to Nasir (2021), curriculum monitoring and evaluation is a critical aspect that should be done to ascertain its sustainability. To ensure curriculum sustainability, monitoring and evaluation can help ensure resource allocation to ensure the smooth running of the project. For example, a curriculum can be developed without considering the long-term goals of the academic and learning process and available resources. For instance, the implementation of CBC has faced the setback of the inadequacy of resources, including infrastructure, human capital, and learning resources. However, the monitoring and evaluation task force commissioned by President Ruto seems to assess the resources needed to ensure the CBC model sustainability; hence could be why the government is recruiting teachers and releasing the capitation grant to ensure the resources needed are available.

Monitoring and evaluation ensure that professional qualifications match curriculum needs by ascertaining that teachers have the qualifications to teach a particular grade.

### **Dynamic Nature of Curriculum**

The curriculum should be monitored and evaluated to ensure the implementers and/or institutions maintain order and stay organized. According to Chen (2023), the curriculum is designed by individuals who intend for learners to get certain skills and knowledge, with the curriculum ought to be monitored and evaluated to ensure that the intended curriculum is implemented and attained (Chen, 2023). They are; ensuring that the curriculum remains aligned with an institution's educational goals and objectives, providing a coherent and effective learning experience for students. Thirdly, it promotes accountability among educators and ensures compliance with educational standards and guidelines.
